Han received his doctorate in Research and Evaluation Methods from the University of Massachusetts at Amherst. He received several awards from the National Council on Measurement in Education (NCME), including the Alicia Cascallar Award for an Outstanding Paper by an Early Career Scholar (2012), the Jason Millman Promising Measurement Scholar Award (2013), and the Annual Award (2017). Chris authored/co-authored numerous book chapters, published articles in peerreviewed academic journals, and technical reports on various topics including but not limited to: computerized adaptive testing (CAT) designs, multistage testing (MST) on-the-fly practices, item parameter drift, IRT models, standard setting, test decision accuracy, and test score reliability. Chansoon Danielle Lee (Ph.D. University of Wisconsin–Madison) is an Assistant Professor of Psychology and Statistics in College of Osteopathic Medicine at Liberty University. Her research interest is predictive modeling using Bayesian model averaging and decision tree models. Also, her research focuses on psychometric approaches for test development and item security in computerized adaptive testing (CAT). The paper entitled "Hybrid Threshold-based Sequential Procedures for Detecting Compromised Items in a CAT Licensure Exam" was submitted for the 2021 KAERA conference (virtual). This study applies sequential procedures to a real operational item pool in a variable-length CAT to detect compromised items. Moreover, this study proposes a hybrid threshold approach to improve the detection power while controlling the Type I error. Dr. Lee has been a KAERA member since 2015 and volunteered for the KAERA conferences as a mentor for doctoral students and a discussant for round-table sessions. As the General Administrator, she currently serves on KAERA. Dr. Lee is deeply honored to receive the KAERA Young Scholar Award and grateful to KAERA for the support for her research.

Outstanding Research Paper Award



Chanwoong Baek (Ph.D.)

I am a postdoctoral fellow in globalization, comparative education, and policy research at the University of Oslo. My research interests include global governance in education, comparative policy studies, and sociology of expertise. Methodologically, I employ both quantitative and qualitative methods, and I have particularly sought to advance the application of social network analysis for understanding the relationship between global and local as well as the structural coupling of politics and science.

I am deeply honored to receive the KAERA Outstanding Research Paper Award for my paper entitled, "Understanding Windows for Global Policy: An Examination of the Free-semester Program in Korea," published in *Compare: A Journal of Comparative and International Education*. In this study, I examine why national policy actors adopt or reframe particular global ideas at a particular time drawing on the case of the Free-Semester Program in Korea. Through this study, I hoped to contribute to the understanding of change in Korean education policy in today's policymaking world, where information and evidence are overtly brought across national boundaries. This paper illustrates the importance of timing in the local adoption of global education ideas and also highlights the emerging role of local policy entrepreneurs. In addition, by demonstrating how policy actors have repackaged existing policy ideas and practices as instances of global policy ideas, this paper argues that there is not only a translation from global to local but also vice versa.

I wish to thank the Award Review Committee for this great honor, and KAERA, the Embassy of the Republic of Korea in the US, and the Korean Ministry of Education for the whole work and support connected with the award.

Based on her teaching experience working with (im)migrant children in Korea and the U.S., her current research focuses on the education of (im)migrant children, critical inquiries with children, and participatory methodology.

I am deeply honored to receive the KAERA Graduate Student Research Award. In the awarded paper titled "Toward Porous and Fluid Critical Inquiries: Centering Learning From Children in Critical Inquiries With Children," I illuminate the complexities and the methodological dilemmas arising in critical inquiries with children. In the paper, I present the lessons I learned from the engagement of migrant Joseonjok elementary schoolers in a critical inquiry project about migrant belonging in South Korea. With the support of this KAERA award, this paper was further developed and accepted at the *International Journal of Qualitative Methods* with the title, "Critical Inquiry with Children as an Unlearning Process: A South Korean Case of Critical Inquiry Centering Learning from Children." I hope many doctoral students apply for the KAERA Graduate Student Research Award in 2022 and have the opportunity to develop their research with the support of the academic community.

Coming Together to Overcome COVID-19 and Other Challenges Facing Koreans and Korean Americans

On November 30, 2021, KAERA held a joint forum with Overseas Koreans Foundation on a theme, "Coming Together to Overcome COVID-19 and Other Challenges Facing Koreans and Korean Americans". Participants from Korea and from various parts of North America attended the virtual event and engaged in an active discussion. The forum started out with Dr. Kim Seong-gon, President of the Overseas Koreans Foundation, introducing the foundation, his visions on Korean-American communities, and its support program. Following Dr. Kim's presentation, Dr. Sohyun An from Kennesaw State University offered a thought-provoking presentation, "Anti-Asian Violence amid COVID-19 Pandemic and Educational Implications". Beginning with Atlanta mass shooting

crime in March 2021, Dr. An stated that discriminations against Asians have taken place throughout US history and this discrimination has recently been aggravated due to COVID 19 outbreak in China. Incidents of bullying, stabbing, and attacking Asians, have increased in the US to the point of recording 10,370 cases in September 2021. Asians, especially Chinese in their immigration history have been targeted for infectious diseases, such as smallpox, bubonic plague, SARS, and so forth, and were forced into quarantine, imprisonment, fumigation, and to accept house burning for disinfection purpose. Asians were also perceived as an economic threat and a military threat to the US. Dr. An stressed that violence against Asians derive from US education system, especially with the school curriculum. Many states do not teach Asian history and many textbooks include images and stories about Asians as a weaker group seeking support and subsidies from the benevolent White heroes. Ignorance can generate more discriminations towards a particular minority group. As such, while education has been the cause of unreasonable discriminations against Asians, education at the same time can offer solutions to the social challenges we encounter nowadays.

Dr. Siyon Rhee also shared her community-based experiences with Korean-Americans living in California and Youngsoo Choi, a New York City attorney, provided critical information for the protection and safety process toward anti-Asian hate crimes. These presentations generate several reflections on our status quo as Asian and Korean immigrants in the US. Not only related to public health but several discriminations and negligence towards Asians have existed in the US. Asians are often portrayed as a model minority as many Asians tend to receive higher levels of education and are economically stable (e.g., Chinese, Korean, Japanese, and Indian). However, this model minority stereotype often creates misconceptions that all Asians are well off, which often results in neglecting population groups that still need much support (e.g., Hmong and Bangladeshis). Furthermore, it has shown that Asians are discriminated in college admissions in some states despite solid academic credentials and a strong zeal for higher education. A limited number of Asians hold senior leadership positions in American corporates or even in the government despite a large number of lvy League graduates.

Regardless of several generations of Asians living in the US, the image of Asian as "a perpetual foreigner" seems to persist. Asians tend to mingle more with the same ethnic groups who share the same language and culture and seem to maintain more of ethnic identity from mother countries. Nevertheless, for Korean Americans for example, born and raised in the US, who have never visited Korea, US is home country for them, not Korea. As more Koreans settle down in the US, more possibilities exist of having a third, fourth, fifth generation and more of Koreans who would call US as their home country. As educators and researchers, how should we address this increasing group of Korean American population? Their Korean ethnic identity may vary depending on which generation one falls into.

As Asians, we Koreans are not free from discriminations against Asians occurring in the US. More challenges against Asians would exist than what I have listed here. I agree with Dr. An that education can offer solutions to our existing challenges. We may not be able to resolve all the problems at once, but little by little, through raising awareness, from putting ideas into practice, we can create ripple effects. In that regard, an organization such as KAERA should unite under a common goal to make a difference. Through sharing of ideas, research, analysis of the educational challenges and seeking solutions, we can improve the status quo. I thank Dr. An for raising our awareness and reminding us of the endless possibilities educators and researchers can achieve.

KAERA Distinguished Researcher Award

Deadline: December 15, 2021

Purpose

KAERA (http://www.k-aera.org/) was established in 2009 with the aim of assisting Korean-American and Korean researchers and students to advance knowledge and practices in education, to encourage scholarly inquiry related to education, and to promote the use of research to improve educational conditions and serve the public good.

The KAERA Distinguished Researcher Award recognizes and honors an individual whose professional contributions over a career have had a widespread positive impact in educational research. These contributions may include important theoretical or methodological developments, applications of educational theory that have influenced substantive research in education or related fields, or innovative ideas that have significantly affected educational theory and practice. This award is given annually to a researcher who has demonstrated exceptional promises and achievements in the creation of new knowledge in education.

Eligibility

The candidate must be a member in good standing of KAERA. Previous awardees are ineligible. Eligible nominees must have demonstrated excellence in educational research and professional service over a career (at least 10 years since completing their doctoral degree). Prior nomination does not exclude a candidate from consideration in subsequent years.

The nomination will be assessed by the following criteria

- 1. Scholarship and Research Accomplishments
 - Impact of discovery and significant effect on practices and research in education
 - Advancing the educational training for various professionals
 - Creating a break-through solution to long-standing problems in education
 - Providing noble and critical insights to address important social issues
- 2. Professional Services & Leadership
 - Significant contributions to professional organizations through leadership and services (with particular emphasis on KAERA service)
 - Leading consulting work, speaking, advocacy, and/or recruitment initiatives
 - Recognized services to regional, national or international organizations
- 3. Overall Impact
 - Theoretical contribution to educational research and influence on others' work

Nomination Process

- 1. Self-nominations are encouraged.
- 2. Candidates can be nominated by any KAERA member.
- 3. Nominations should include the following
 - A completed nomination form
 - A brief statement explaining why the researcher should be considered for the award
 - Curriculum vitae of the nominee
 - One letter of support (optional)

Announcement and Presentation of Award

The KAERA Distinguished Researcher Award committee will make the final selection from the list of nominees and the winner will be announced through KAERA listserv and KAERA Newsletter. A cash award of \$1,000 and an award certificate will be presented at the conference. (The award recipient will serve as a one-year member on the 2022-2023 award committee.)

The KAERA Outstanding Research Paper Award has been established with support from the Embassy of the Republic of Korea in the United States, and the Ministry of Education of the Republic of Korea, in order to recognize an exceptional research paper that addresses critical educational issues facing Koreans and overseas Koreans (including Korean Americans). The Award aims to provide recognition of innovative scholarly work that advances the field of educational research and promotes educational experiences and opportunities for the children and youth of Korean ancestry around the world.

Eligibility

A paper accepted for publication in any peer-reviewed journal between 2020 and 2021 are eligible. At least one author of the nominated paper has to be a current member of the KAERA.

Nomination Process

Self-nominations are encouraged.

Nominations should include the following

- an electronic copy of the nominated paper
- a nomination form (attached)
- a brief statement explaining why the paper should be considered for the award. Specifically, describe which
 critical educational issue the paper is addressing, why this educational issue matters and for whom, how the
 paper contributes to the understanding of this issue, and what implications this paper offers for improving
 educational policy and/or practice.

Announcement and Presentation of Award

The winning paper(s) will be selected by the KAERA Outstanding Research Paper Award Committee. Awardees are expected to be announced no later than February 14, 2022. The author(s) of the winning paper(s) will be required to present their research paper during the 2022 KAERA Conference in April, 2022. A cash award and the award certificate will be presented at the conference.

Call for Proposal 2022 Virtual Conference

Deadline: December 31, 2021

You are cordially invited to submit a proposal for the 2022 Korean-American Educational Researchers Association (KAERA; http://www.k-aera.org) Virtual Conference, which takes place on April 22, 2022. The mission of the KAERA is to promote intellectual dialogues among scholars in broadly defined education disciplines through research that examines critical issues of the field and offers implications for education practice and policies.

The theme for the 2022 KAERA conference is "Cultivating Equitable Education for Korean/Korean Americans in the 21st Century" The conference will consist of keynote speeches, mentoring sessions, and round table research presentations. We want to highlight that roundtable sessions in the 2022 conference will feature the small groups and detailed feedback from discussants. We welcome proposals for both individual papers and work-in-progress research.

All proposals will be reviewed by at least two reviewers and the discussants with expertise in topics will provide constructive and detailed feedback on each proposal. We highly encourage graduate students, along with other researchers, to consider submitting their scholarly work for the insightful feedback from the discussants. Presentations can be delivered in languages (English and/or Korean) chosen by presenters.

The conference is open to all educational researchers regardless of nationality, country of origin, or specific fields of education. Therefore, KAERA welcomes research proposals that cover an array of topics that meet the broad needs and research interests of KAERA members and other education researchers.

A proposal between 750 and 1,000 words (excluding abstract, references, figures and tables) in length will be considered for the small group research presentations. It should include (1) an abstract (less than 100 words) and keywords, (2) objectives or purposes, (3) perspective(s) or theoretical framework, (4) methods, (5) results/preliminary results, and (6) implications or significance.

A proposal must be submitted through the link by December 31, 2021, 11:59pm (PST). Please note that you need a Google account to submit your proposal. Result notification will be sent out by February 12, 2022. If your proposal is accepted, you will be asked to submit a full paper by March 14, 2022.

Once a proposal is accepted and its full paper is submitted, it may be considered for KAERA Awards: Two awards for graduate students (\$500 per award).

One award for a young researcher(s) (\$500) who earned a doctorate within six years at the moment of presentation.

The 2022 KAERA conference will feature various sessions for graduate students, faculty, and researchers to engage in intellectual and professional dialogues as well as to build up social and research networks.
