### 2019 KAERA 10th Annual Meeting

A total of 145 participants participated in the 10th Annual Meeting at the Westin Harbour Castle in Toronto on April 5. The conference titled "Democratizing Educational Research Evidence in a Post-Truth Era: Bridging the Divide" consisted of six major sessions: opening plenary, special symposium sessions, roundtable session, mentor & mentee session, 10th anniversary ceremony, and business meeting followed by a reception dinner.

### 2019 KAERA 10th Annual Meeting (Continued)



The opening plenary consisted of presentations by Jaebum Song (President of the Seoul Education Research & Information Institute; SERII), Sang-Jin Ban (President of Korea Educational Development Institute; KEDI), Moonkyoo Shin (Minister Counselor for Education in the Embassy of the Republic of Korea to U.S.A), and Byung-Seung Lee (Education Director of the Korean Education Centre in Canada). The special symposium session involved two presentations: *Design and Implementation of "Seoul Education Longitudinal Study 2020"* by Song Jung and Unkyung No (Research fellows at the Seoul Education Research & Information Institute), and *Prospects and Tasks for Changes in High School Education Environment of Korea: From Students' Point of View* by Cholkyun Shin (Assistant Professor at Kangwon National University) and Ji-Hye Kim (Associate Research Fellow at KEDI). The discussant of this session was SSang-Cheol Lee (Director of Democratic Citizenship Education Research Office at KEDI).

The round tables focused the following seven areas: (1) Curriculum & Instruction, (2) Educational Measurement & Research Methodology, (3) Education Policy, (4) Educational Psychology & Counseling, (5) Educational Technology/ Instructional Design, (6) Special Education & Counseling, and (7) Teacher Education. The mentoring session was led by Sohyun An (Associate Professor of social Studies Education at Kennesaw State university). A total of 19 faculty volunteered to be a mentor for 26 graduate students, and 20 mentor-mentee groups were formed. To celebrate KAERA's 10th anniversary meeting, Hyunsoo Hur (Associate Professor at the Defense Lange Institute) led the celebration session with four multi-generation Korean scholars: Kwang Suk Yoon (1st KAERA Present, 2009-10), Jae Hoon Lim (5th KAERA President, 2013-14), Bong Gee Jang (Current Communication Director; representative junior scholar), and Mina Lee (Graduate student at the University of Massachusetts).

Lastly, during the business meeting (award recognition), the following people were recognized: Yoonjung Choi (Ewha Womans Unviersity) and Yeji Kim (Columbia University) for KAERA Outstanding Research Paper Award. The winners for KAERA Graduate Student Best Paper Award were Dosun Ko and Joan Jaejin Hong, from University of Wisconsin-Madision, and Misun Kim, Kathleen Palmquist, and Jung-in Kim from University of Colorado Denver. The KAERA Young Researcher Award were given to Katie Koo (Texas A & M University-Commerce), Young Won Kim (University of Washington), and Joon Yong Lee (University of North Texas), and the KAERA Distinguished Researcher Award was given to Okhee Lee (New York University, Steinhardt).

### 2020 KAERA Conference Call for Proposal

### Application deadline: December 14, 2019

You are cordially invited to submit a proposal for the 2020 Korean-American Educational Researchers Association (KAERA; <a href="http://www.k-aera.org">http://www.k-aera.org</a>) Conference in San Francisco, California on April 17 (Friday), 2020. The mission of the KAERA is to promote intellectual dialogues among scholars in broadly defined education disciplines through research that examines critical issues of the field and offers implications for education practice and policies.

The theme for the 11th KAERA conference is "Local and Global Collaboration for the Public Good". The conference will consist of a presidential panel session, roundtable research presentations, a SIG mentoring session, and a business meeting. All proposals will be blind-reviewed by at least two reviewers of the KAERA Program Planning Committee. The conference is open to all educational researchers regardless of nationality, country of origin, or specific fields of education. Therefore, KAERA welcomes research proposals that cover an array of topics that meet the broad needs and research interests of KAERA members and other education researchers.

A proposal between 750 and 1,000 words (excluding abstract and references) in length will be considered for the roundtable research presentations. It should include an abstract (less than 100 words) and keywords, objectives or purposes, perspective(s) or theoretical framework, methods, results, and implications or significance. Result notification will be sent out by January 15, 2020. If your proposal is accepted, you will be asked to submit a full paper by April 1, 2020.

A proposal must be submitted through the link: <a href="https://forms.gle/bGNKV8EHPLMpNSUv6">https://forms.gle/bGNKV8EHPLMpNSUv6</a> by December 14, 2019. Please note that you need a Google account to submit your proposal.

Once a proposal is accepted and its full paper is submitted, it may be considered for the awards including:

- Two awards will be granted to graduate students (\$500 per award).
- One award will be granted to a young researcher(s) who earned a doctorate within six years at the moment of presentation.

In the research roundtable session and following meetings, outstanding discussants and mentors will provide useful, practical advice aimed at enhancing in-depth discussions among graduate students, junior faculty members, and other researchers. Please do not miss out on a great opportunity to meet with them at the KAERA conference.

### KAERA Outstanding Research Paper Award Call for Submissions

#### Purpose:

The KAERA (http://www.k-aera.org/) was established in 2009 with the aim of assisting Korean and Korean-American researchers and students to advance knowledge and practices in education, to encourage scholarly inquiry related to education, and to promote the use of research to improve educational conditions and serve the public good.

The KAERA Outstanding Research Paper Award has been established with support from the Embassy of the Republic of Korea in the United States, and the Ministry of Education of the Republic of Korea, in order to recognize an exceptional research paper that addresses critical educational issues facing Koreans and overseas Koreans (including Korean Americans). The Award aims to provide recognition of innovative scholarly work that advances the field of educational research and promotes educational experiences and opportunities for the children and youth of Korean ancestry around the world.

#### Eligibility:

- 1. A paper accepted for publication in any peer-reviewed journal between 2018 and 2019 are eligible.
- 2. At least one author of the nominated paper has to be a current member of the KAERA.

#### **Nomination Process:**

- 1. Self-nominations are encouraged.
- 2. Nominations should include the following:
  - an electronic copy of the nominated paper,
  - a nomination form (attached) and
  - a brief statement explaining why the paper should be considered for the award. Specifically, describe which critical educational issue the paper is addressing, why this educational issue matters and for whom, how the paper contributes to the understanding of this issue, and what implications this paper offers for improving educational policy and/or practice.

### **2020 KAERA Awards**

#### KAERA Distinguished Researcher Award Call for Submissions

#### **Purpose**

KAERA (http://www.k-aera.org/) was established in 2009 with the aim of assisting Korean-American and Korean researchers and students to advance knowledge and practices in education, to encourage scholarly inquiry related to education, and to promote the use of research to improve educational conditions and serve the public good.

The KAERA Distinguished Researcher Award recognizes and honors an individual whose professional contributions over a career have had a widespread positive impact in educational research. These contributions may include important theoretical or methodological developments, applications of educational theory that have influenced substantive research in education or related fields, or innovative ideas that have significantly affected educational theory and practice. This award is given annually to a researcher who has demonstrated exceptional promises and achievements in the creation of new knowledge in education.

#### Eligibility

- 1. The candidate must be a member in good standing of KAERA. Previous awardees are ineligible. Eligible nominees must have demonstrated excellence in educational research and professional service over a career (at least 10 years since completing their doctoral degree). Prior nomination does not exclude a candidate from consideration in subsequent years.
- 2. The nomination will be assessed by the following criteria:
  - -Research Accomplishments:
    - \*Impact of discovery
    - \*Original research in peer-reviewed journals and other publications (e.g., book, book chapters, editorials)
    - \*Peer-reviewed research presentations (e.g., lecture, panel)
    - \*Research support generated through grants and contracts (e.g., federal, foundation, industry)
  - Recognition
    - \*Positions in peer-reviewed journals
    - \*Membership in grant review panels
    - \*Regional, national or international organizational services relating to research, recognition or awards, and/or guest speak invitations

#### **Nomination Process**

- 1. Self-nominations are encouraged.
- 2. Candidates can be nominated by any KAERA member
- 3. Nominations should include the following:
  - A completed nomination form;
  - A brief statement explaining why the researcher should be considered for the award;
  - Curriculum vitae of the nominee; and
  - One letter of support (optional)
